Has never been disciplined or convicted for any crime related to fraud or any other financial and accounting misconducts;5. There must be at least 2 accounting experts and higher diploma in case it is a private enterprise;6. At least 3/5 of the shareholders are all accounting experts, the executives, and the senior staff in case of two or more shareholders. |
