- Persons eligible for protection of industrial property shall be as follows:1. a Lao citizen or resident in the Lao PDR, or a legal entity or organizationestablished under the laws of the Lao PDR; 2. an individual that is a national or a resident of any country which is a member of the Paris Convention or other international agreement relating to the protection of industrial property and of which the Lao PDR is also a member; 3. an individual, legal entity or organization with a real and effective industrial or commercial establishment in the territory of any member of the Paris Convention or of any other international agreement that relates to the protection of industrial property and of which the Lao PDR is also a member.international agreement that relates to the protection of industrial property and of which the Lao PDR is also a member.- A layout-design of integrated circuit eligible for lay-out design of integrated circuit certificate shall meet all the following requirements:1. the layout-design is original which is not similar to the layout-design of others which is created from an idea of a creator and is not commonplace among creators of layoutdesigns and manufacturers of an integrated circuit at the time of its creation; 2. the layout-design consists of an integration of elements and interconnections that are commonplace shall be protected only if the combination, taken as a whole, fulfills the conditions of item 1;3. the application for registration is submitted before the layout-design circuit is commercially exploited anywhere in the world by the right holder or within two years from the date of commercial exploitation.
