<b>Qualifications needed by the business to get the formality</b>	1. Having a stable financial status;2. Having sufficient knowledge, skills, and experience related to the work;3. Having an appropriate office, sufficient vehicles, and equipment in accordance with the size of the business;4. Having paid the fees and service charges in full;5. Completing the required documentation.

<b>What is the process and conditions to renew the formality?</b>	1. Terms for the license are as follow: (i) 15 years for Type I; (ii) 10 years for Type II; (iii) 5 years for Type III; and (iv) 3 years for Type IV2. The renewal shall be undertaken within 30 working days prior to its expiry date. If it cannot be renewed within this timeframe, the written explanation shall be given to the relevant authority, or else it will be deemed that they intend to stop their operation and the authority will terminate the license.
