<b>Qualifications needed by the business to get the formality</b>	The object to be exported shall be the replica, not the authentic artifacts as proven by the authority; provided that the applicant shall submit (i) the document showing the registry number and description of such artifacts; and (ii) the purchase-sale evidence of such artifact replicas.
