Must operate the business within one year and in accordance with the laws of the Lao PDR. The applicant must prepare documents as the following: Application form, Color Photo size 3x4 = 2, previous License, power of attorney (In case of designate other person or representatives of companies to apply for the renewal), certificate of tax payment, business operation summary, financial reports.
