Have a fundraising and investment plan for the mutual funds5. Have an internal control system, risk management, Information technology, and conflicts of interest prevention within the company, with the company, person, or other related legal entity6. Shareholders that established as an asset management company must be in a good financial position and must be audited by an external audit company.7. Other conditions as determined by the LSCO
